II. Presentation: Tatiana Wells, Early Learning Navigator, Cleveland Central Promise Neighborhood		
Discussion Points	• Modeled after the Harlem Children's Zone, Cleveland Central Promise Neighborhood (CCPN) started in 2010 with the goal of ensuring that children and their families are resilient, thriving, and receive a quality education. The number of quality childcare programs in the CCPN has steadily risen, with 9 highly rated centers, the majority of whom are also designated as Ohio Healthy Programs. CCPN also provides other supportive services for young children and families, including memberships to the Children's Museum, Read and Ride, SPARK home visiting, and the Imagination Library. CCPN also supports the K-12 system through scholarship support, trauma-informed care training, and high school transition. Language and literacy are the biggest challenges
